## 4. FIRST AID MEASURES

#### Inhalation:

### **6. ACCIDENTAL RELEASE MEASURES**

#### Personal Precautions, Protective Equipment and Emergency Procedures:

Wear approved dust/particulate filter respirator and full protective clothing. Evacuate all non-essential personnel from affected area. Do not breathe dust. Ensure adequate ventilation. Avoid generating dust.

#### **Environmental Precautions:**

In the event of a major spill, prevent spillage from entering drains or water courses.

#### Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so and sweep granules into a pile and shovel into drums for subsequent disposal. Avoid generating dust. Provide adequate ventilation. Wash away uncontaminated residue with water.

## 7. HANDLING AND STORAGE
