## Section 4 - First Aid Measures

**General Information:** You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. ## Section 6 - Accidental Release Measures

**Accidental release:** Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. Prevent spillage from entering drains or water courses. This material may be suitable for approved landfill.

*Exposure limits have not been set by SWA for any ingredients in product.
