Section 4 - First Aid Measures

Skin Contact: Wash affected areas with water until chemical is removed. Remove all contaminated clothing and laundry before re-use. If in doubt obtain medical advice.

Section 6 - Accidental Release Measures

Spillage: Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses.
