DIRECTIONS FOR USE

MIXING INSTRUCTIONS

Beekeeper is suitable for use in conventional spray equipment (ground/aerial/hand). Shake Beekeeper well before using and mix with sufficient water to ensure adequate and even coverage. Agitate tank mixture during applications and use immediately.

RECOMMENDED CROPS

Fruit & Nut Crops: Almond, Apple, Apricot, Avocado, Blackberry, Blueberry, Cranberry, Gooseberry, Cherry, Grapefruit, Honey Dew, Lemon, Limes, Macadamia, Mandarin, Mango, Melon, Nectarine, Oranges, Peach, Pear, Persimmon, Plum, Pomegranates, Prune, Raspberry, Strawberry, Tangelo, Tangerine and Tomatoes.

Vegetable Crops: Asparagus, Broccoli, Brussel Sprouts, Carrots, Cauliflower, Celery, Chinese Cabbage, Collard, Cucumber, Dill, Eggplant, Garlic, Kale, Kohlrabi, Leek, Lima Beans, Mustard, Parsley, Peas, Pepper, Pumpkin, Radish, Rutabaga, Squash, Turnip.

Forage & Legume Crops: Alfalfa, Clover, Vetch.

Oilseed Crops: Cotton, Flax, Rape, Safflower, Soybeans, Sunflower.

APPLICATION

Apply Beekeeper at the rate of 2 Litres/hectare during early (10% to 20%) bloom and at 6 to 10 day intervals throughout bloom period. Rain following product application may reduce the effectiveness of the application, making additional applications necessary.

COMPATIBILITY

Beekeeper is most effective when applied with water. DO NOT apply with pesticides toxic to bees.

STORAGE AND DISPOSAL

KEEP OUT OF REACH OF CHILDREN. Store in the closed, original container in a well-ventilated, area as cool as possible. DO NOT store for prolonged periods in direct sunlight. DO NOT store with seeds, foodstuffs or fertilizer. Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulation. DO NOT burn empty containers or product.
