HOW TO USE

USE THIS PRODUCT ONLY AS DIRECTED. SHAKE CAN WELL BEFORE USE.

Apply a light spray to carpet and pet bedding where adult fleas are present or suspected of being active.

Hold can at a distance of approximately 30 to 50 centimetres to apply spray.

Re-apply to carpet surfaces after vacuuming.

Re-apply to pet bedding after it has been washed and dried.

If necessary, re-apply monthly.

NOT TO BE USED FOR ANY PURPOSE, OR IN ANY MANNER, CONTRARY TO THIS LABEL UNLESS AUTHORISED

Precautions: KEEP OUT OF REACH OF CHILDREN. Do not spray directly onto humans, pets, exposed foods, food utensils or food preparation surfaces.

Re-entry: Do not enter treated areas until the spray has dried.

FLAMMABLE Do not store or use near fire or flame. Do not spray uninterrupted for more than 10 seconds in confined spaces. Ensure good ventilation.

BEWARE: Deliberately sniffing or inhaling concentrated spray can be harmful or fatal.

Avoid spraying at close proximity to painted surfaces. Concentrated application to some painted surfaces may cause damage. If in doubt, apply a small test spray and wait 24 hours before applying to larger areas.
