# Section 4 - First Aid Measures

**General Information:** You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia and is available at all times. Have this SDS with you when you call.

**Inhalation:** Inhalation is not normally harmful. Recovery is rapid after removal from exposure. If symptoms are experienced, remove victim to fresh air. Seek medical attention if irritation persists or breathing difficulties arise

**Skin Contact:** Remove contaminated clothing and wash thoroughly with soap and water. Seek medical attention if irritation develops. Launder clothing before reuse.

**Eye Contact:** Hold eye open and flush gently with copious amounts of water for 15 minutes and seek medical attention.

**Ingestion:** If swallowed, immediately rinse mouth out with water. Give copious quantities of water to drink. Contact Poisons Information Centre or doctor immediately. **Do not induce vomiting.**

### Section 6 - Accidental Release Measures

**Spillage:** Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Stop leak if safe to do so, and contain spill. Sweep up and shovel or collect recovered product into labelled containers for recycling or salvage, and dispose of promptly. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. This material may be suitable for approved landfill. Ensure legality of disposal by consulting regulations prior to disposal. Thoroughly launder protective clothing before storage or re-use. Advise laundry of nature of contamination when sending contaminated clothing to laundry.

## Section 7 - Handling and Storage

*Handling:* Before use carefully read the product label. Use of safe work practices are recommended to avoid eye or skin contact and inhalation. Observe good personal hygiene, including washing hands before eating. Prohibit eating, drinking and smoking in contaminated areas.

**Storage:** Store in cool, dry, well ventilated area removed from combustible materials, herbicides, fungicides and foodstuffs. Ensure containers are labelled, protected from physical damage and sealed when not in use. Keep from extreme heat and open flames and make sure that the product does not come into contact with substances listed under "Materials to avoid" in Section 10. Bagged fertilisers should be stored under cover and out of direct sunlight.



## Section 8 - Exposure Controls and Personal Protection

Exposure limits have not been set by SWA for any ingredients in product. The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. There is a blanket limit of 10mg/m<sup>3</sup> for dusts or mists when limits have not otherwise been established. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak "is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly. ADI means Acceptable Daily Intake and NOEL means No-observable-effect-level. Values taken from Australian ADI List, 31<sup>st</sup> March 2012

#### **Personal Protection**

## Section 11 - Toxicological Information

### Potential Health Effects
