## Section 4 - First Aid Measures

**General Information:** You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. **Inhalation:** If mists have been inhaled, and irritation has developed, remove to fresh air and observe until recovered. If irritation becomes painful or persists for more than about 30 minutes, seek medical advice

**Skin Contact:** Wash affected areas with water until chemical is removed. Remove all contaminated clothing and laundry before re-use. If in doubt obtain medical advice.

## Section 6 - Accidental Release Measures

**Spillage:** Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses.
