## Section 4 - First Aid Measures

### General Information:

## Section 6 - Accidental Release Measures

**Accidental release:** Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. Wear protective clothing including impervious gloves and safety goggles. All skin should be covered. Thoroughly launder protective clothing before storage or re-use. Stop leak if safe to do so, and contain spill. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. ## Section 7 - Handling and Storage

**Handling:** Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. **Storage:** Store in cool, dry area removed from foodstuffs. Ensure containers are labelled, protected from physical damage and sealed when not in use. Do not allow to come into contact with water either from rain, condensation or the surface on which it is stored. Bagged fertilisers should be stored under cover and out of direct sunlight.
