### Section 3 - Composition/Information on Ingredients

### Section 4 - First Aid Measures

**General Information:** You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. **Inhalation:** If mists have been inhaled, and irritation has developed, remove to fresh air and observe until recovered. If irritation becomes painful or persists for more than about 30 minutes, seek medical advice.

**Skin Contact:** Wash affected areas with water until chemical is removed. Remove all contaminated clothing and launder before re-use. If in doubt obtain medical advice.

**Eye Contact:** Immediately irrigate with copious amounts of lukewarm, gently flowing water for 15 – 20 minutes or until the product is removed or irritation has ceased, while holding the eyelid(s) open. Obtain medical advice if irritation becomes painful or lasts more than a few minutes.

**Ingestion:** Give a glass of water if affected person able to drink. Do not induce vomiting unless instructed to do so by medical advice.

**Notes to Doctor:** Treat symptomatically.

### Section 5 - Fire Fighting Measures

### Section 6 - Accidental Release Measures

**Spillage:** Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. Full details regarding disposal of used containers, spillage and unused material may be found on the label. If there is any conflict between this SDS and the label, instructions on the label prevail. ### Section 7 - Handling and Storage

**Handling:** Before use carefully read the product label. Use of safe work practices are recommended to avoid eye or skin contact and inhalation. Observe good personal hygiene, including washing hands before eating. Prohibit eating, drinking and smoking in contaminated areas.

**Storage:** Store in cool, dry, well ventilated area removed from combustible materials, herbicides, fungicides and foodstuffs.
